563/18 Matters arising from Previous Minutes

- a] Treburrick Traffic calming The 30mph and Slow down signs in Treburrick that the PC had made and paid for have been stolen. It was agreed to meet with CC, to establish if an alternative solution can be arranged.
- b] Porthcothan toilets There is disagreement regarding the cost of cleaning when the Toilets are closed.
- c] Blue Seas planning The Pc were represented at a recent Planning Committee meeting where the Planning Application was successful.

564/18 Planning Applications

a] PA17/12251 Mr & Mrs Tudor, Roscarrock, Porthcothan. Proposed erection of replacement detached dwellinghouse. To include erection of detached outbuilding/store and associated external hard landscaping works. Before discussion the Architect for this Planning Application explained to the Councillors his reasons for the design and the effort he has made to fit the new building into the surrounding environment. The Councillors then had No Objection to this Planning Application. Prop: MN Sec JF There was a split decision.

b] PA18/00791 Mr Bennison, land at Efflins, St Eval. Variation of Conditions 2,4 & 6 in respect of decision PA16/02689 [Conversion of building to holiday accommodation] in order to reflect the amended design.

The Councillors voted to Object to this Application. They felt that it was a poor contrived design not in keeping with the other properties near the site. Also the Parish Council is not aligned to new holiday accommodation development. Better use of materials and a better design is required. Prop: MW Sec JF All Supported.

c] PA18/00901 Mrs Kate Cavalier, Burgeys, road from Engollan to Downhill, single storey side & rear extension.

The Councillors voted to Object to this Application. They felt that the flat roof was a poor design that did not compliment the house it would be attached to. Also the size of the development is too large in relation to the existing property. Prop: MN Sec: PS All Supported
