675/19 **Planning Applications**

a] PA18/09749 AJL Ltd. Land East of Porthcothan Bay. Proposed change of use of land to form seasonal campsite with 2 ablution blocks and 1 office block in the form of containers, from May to November inclusive. The Councillors voted to object to this Application unanimously. Prop: MW Sec: GA All Supported.

b] PA18/ 00516 & 00517 The National Trust Pentire Farm Car Park, Park Head. Installation of one Pay & display machine & related instruction signage. Advertising consent for Instruction sign explaining how to use the Car Park charging machine. The Councillors voted No Objection to these Applications.

676/19 **Porthcothan Car Park**
SC stated that he had spoken to the Portfolio holder regarding the painting of the Bays in the car park and will follow up on this conversation.

677/19 **Porthcothan Toilets Lease**
The lease is required to be finalised. The Clerk will ask for the 6 month termination clause to be included.

678/19 Boundary Commission – Cornwall Review Final Recommendations

SC confirmed that St Eval would be included with Padstow, St Merryn, St Ervan and St Issey in the new Electoral arrangements that are now in the final Recommendations. This is due to CC reducing the number of Councillors from 123 to 87.
